## REGULAR SESSION MINUTES

The Regular Session meeting of the Rock Falls Township High School Board of Education was called to order on Wednesday, October 21, 2009, at 7:00 p.m. in Room 137 at Rock Falls Township High School by Board President Wagner. Members present: Howard, Jacobs, Janssen, and Wagner. Members absent: Brackemeyer, Gaulrapp, and Nehrkorn.

President Wagner requested an approval of the agenda. All ayes: Howard, Jacobs, Janssen, and Wagner.
