REGULAR SESSION MINUTES

The Regular Session meeting of the Rock Falls Township High School Board of Education was called to order on Wednesday, October 16, 2019, at 6:30 p.m. in Room 137 at Rock Falls Township High School by President Gaulrapp. Members present: Gaulrapp, Jacobs, Janssen, Lillpop, and Lewis. Board Members Absent: Carlson and Howard.

The Pledge of Allegiance was recited.

A motion was made by Janssen and seconded by Jacobs to enter into a Closed Session meeting to discuss: The Appointment, Employment, Compensation, Discipline, Performance, or Dismissal of Specific School District Employees and or Public Office; Matters Related to Litigation at 6:30 p.m. All ayes: Jacobs, Janssen, Lillpop, Lewis, and Gaulrapp. Also in attendance were: Superintendent Ron McCord and Administrative Assistant Toni Cain. **MOTION CARRIED**

The Public Budget Hearing of the Rock Falls Township High School Board of Education was called to order on Wednesday, September 25, 2019 at 6:50 p.m. in Room 137 at Rock Falls Township High School by Board President Gaulrapp. Members present: Gaulrapp, Jacobs, Janssen, Lillpop, and Lewis. Board Members Absent: Carlson and Howard.

Mr. McCord distributed an amended final budget. The amended final budget reduced the Working Cash Fund and Debt Services Fund interest transfers to the Education Fund by \$10,800 in order to match the budgeted transfer amounts within the Working Cash and Debt Services Fund.

A motion was made by Lillpop and seconded by Jacobs to approve the Public Budget Hearing Agenda. All ayes: Lewis, Jacobs, Janssen, Lillpop, and Gaulrapp. **MOTION CARRIED**

Superintendent McCord presented the 2019-2020 School District Budget which has been on public display for 30 days. Mr. McCord highlighted the differences between the tentative and final budget. The 2019-2020 Budget is a Balanced Budget.

Mr. McCord would like to publicly thank Mrs. Berogan and Mrs. Zollinger for their hard work and efforts put forth on the budget.

2019-2020 Sixth Day Enrollment Figures

Superintendent McCord presented the Sixth Day Enrollment figures: Seniors-153, Juniors-163, Sophomores-169, Freshmen-154, Total In-house-639, Alternative School-10, Total Out-of-Building-11, Homebound-3, and Parochial Students going to WACC-15. Total all Students-678.

2019-2020 WACC and Bi-County Enrollments

Superintendent McCord presented the 2019-2020 enrollment figures for RFHS students and in-district private school students enrolled in the Whiteside Area Career Center (WACC) and the Bi-County Special Education Cooperative. A total of 54 students are enrolled in WACC (43 from RFHS and 11 from Parochial Schools). A total of 131 special education students enrolled at RFHS have Individualized Education Plans (16 out-of-building and 115 in-building).

2019-2020 Feeder Schools Enrollments

Superintendent McCord discussed projected enrollment figures through the 2028-2029 school year. Projected enrollment figures range from a low of 533 students (2026-2027 school year) to a high of 624 students (2020-2021) school year.

2019-2020 Fall Sports Participation Numbers

Athletic Director Rich Montgomery provided a handout with the Fall Sports participation numbers.

Administrator and Teacher Salary and Benefits Report (FY19)

Superintendent McCord presented the 2019-2020 Administrator and Teacher Salary and Benefits Report. This report is based on the amounts paid to administrators and teachers during the 2018-2019 school year (FY19). This report will be sent to the ISBE and has been posted on the school district's website.
